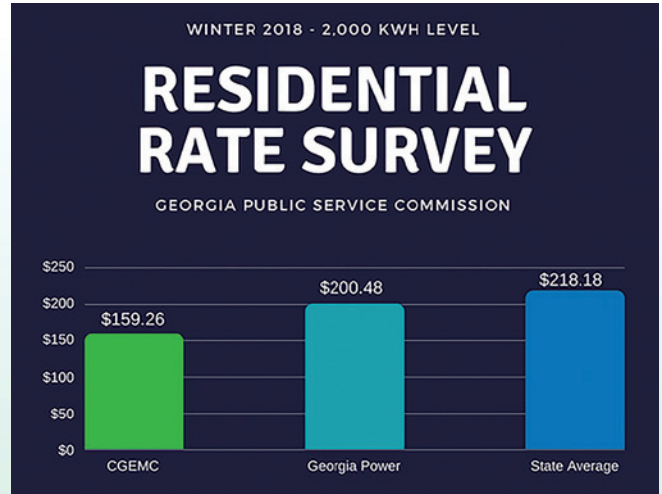
Central Georgia EMC Keeping Energy Affordable

We are excited to announce that Central Georgia EMC (CGEMC) once again ranks as one of the lowest-cost electric providers in the state! According to the 2018 Georgia Public Service Commission (PSC) winter residential rate survey, CGEMC ranks second lowest at both the 1,500 kilowatt-hour (kWh) and 2,000 kWh usage levels among all 94 electric providers in Georgia.

CGEMC customer-owners at the 1,500 kWh usage level save \$38.30 per month over the state average and \$24.92 over Georgia Power customers. At the 2,000 kWh-per-month level, **CGEMC is \$58.92 less than the state average** and \$41.22 less than Georgia Power.



These rankings are proof that our board, staff, and employees are committed to delivering reliable, competitively priced electricity, and to bringing greater savings and overall value to our customer-owners. We work hard to diversify our energy mix, combining traditional and green energy options, and we encourage energy efficiency so that everyone saves.

The Georgia PSC winter survey ranks electric providers on rates in effect for the month of January, based on total electric bill amounts of 500, 1,000, 1,500, and 2,000 kWh. 

Listen Out for Utility Scams

Central Georgia EMC warns customer-owners to be on high alert for phone scammers who falsely claim they are with the utility and demand payment or threaten immediate disconnection. This scam has been targeting utility customers across the United States for some time, and CGEMC is seeing an increase in phone scam activity throughout its service territory.



The scammer may pressure you to pay using a prepaid debit card, instructing you to purchase one and call them back with the card information. Prepaid debit cards are not linked to a bank account and—just like cash—are untraceable. In some cases, the scammer instructs the customer to go to a third-party location to transfer funds to pay the bill.

Oftentimes, the scammer will falsify the information transmitted to the caller ID display so that it appears the call is coming from Central Georgia EMC. While CGEMC does make courtesy calls regarding past-due accounts to avoid disconnection of service, we will never require a specific form of payment, nor will we demand that you make a payment using a third party.

If you doubt the legitimacy of a call, hang up and contact us directly. Central Georgia EMC customer-owners can always verify their account balance by calling us at 770-775-7857 or 1-800-222-4877, using the CGEMC mobile app, or online at www.cgemc.com.

Central Georgia Electric Membership Corporation Announces its Unclaimed Capital Credit Checks for 2017

Central Georgia EMC is a not-for-profit organization. This means any excess revenue, after covering operating costs, is returned to our customer-owners in the form of a capital credit check (based on each customer-owner's energy use).

In December 2017, Central Georgia EMC issued capital credit refund checks for the remaining margins of 1998, all of 1999, and a portion of 2000. However, some of the refund checks issued were returned by the U.S. Postal Service as "undeliverable." Clean Energy, Green Future

As a part of our ongoing commitment to maintain a balanced energy mix, we are proud to offer alternative sources of environmentally friendly renewable energy through Green Power EMC, which is composed of CGEMC and 37 other electric cooperatives in Georgia.

As a member of Green Power EMC, CGEMC offers electricity generated from biomass, specifically methane gas reclaimed from the Taylor County landfill. The clean energy generated through this process is transmitted through the energy grid and is available to customer-owners in 150-kilowatt-hour blocks for \$4.50 per month.

By utilizing generation methods such as this, we can lessen the impact that producing electricity has on the environment. Our clean energy program is Green-e Energy Certified by the Center for Resource Solutions. Green-e Energy certification and verification of a renewable energy program is essential so you can be confident the renewable energy you purchase meets the highest of standards.

For comparison, the current average mix of resources supplying Central Georgia EMC includes: Coal (7.41%), nuclear (22.72%), oil (0%), natural gas (65.9%), hydroelectric (3.74%), and other (0.23%).

Grilled Asparagus

From the kitchen of Mike Hurt



Ingredients:

- 1 pound fresh asparagus
- 3 tablespoons balsamic vinegar
- 2 tablespoons fresh lemon juice
- 1 tablespoon olive oil
- 1/8 teaspoon black pepper
- 1 tablespoon soy sauce
- Cooking spray

Directions:

Prepare grill; snap tough ends off asparagus. Combine all ingredients except cooking spray in a large resealable zipper storage bag. Seal and marinate for 30 minutes to 1 hour. Remove marinated asparagus from bag and discard marinade. Place asparagus on grill rack coated with cooking spray; grill 5 minutes on each side or until asparagus is tender and crisp.
