VOTING OF MEMBERS

In accordance with the Bylaws of the Corporation, the following information applies to voting:

- Only members are eligible to vote. A member is one who has paid a membership fee, signed an application for service (or paid the initial invoice for electric service), and has been approved for membership.
- Each member is entitled to only one vote on each matter submitted to a vote at a meeting of the members.
- Any two or more people holding a joint membership are entitled to only one vote. The vote of either or all shall constitute, respectively, one joint vote provided, that if all are present, but in disagreement on such vote, each shall cast only an appropriate fractional vote.

Recipe of the Month



Honey Bun Cake

From the kitchen of Kay S. Long

Ingredients:

1 box yellow cake mix
3/4 cup vegetable oil
1/4 cup water
8 ounces sour cream
4 large eggs
1 cup light brown sugar
1 tablespoon cinnamon

Glaze:

2 cups powdered sugar
4 tablespoons milk
1 teaspoon vanilla extract

Directions:

Mix well the first five ingredients. Pour half of the batter in a well-greased (may opt to use non-stick cooking spray) and floured 9-by-13 -inch pan. Mix brown sugar and cinnamon. Sprinkle over cake mix in pan. Add the remaining batter to pan; swirl with a spoon. Bake at 325 degrees for 50 minutes.

Mix glaze ingredients and pour over cake while hot from the oven.

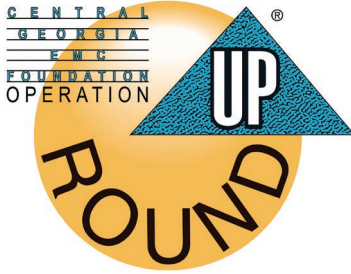
