



CGEMC Providing Reliable Service

In 2014, Central Georgia EMC completed a three-year smart grid upgrade to our distribution system with the implementation of Fault Location, Isolation, and Service Restoration (FLISR) software. With FLISR deployed, CGEMC expected to reduce both the size of outages and length of restoration times. FLISR uses electronic reclosers and communication networks to sense a fault automatically, isolate power line damage, and restore service to as many customers as possible.



Now that the system has been in operation for more than a year, we would like to share some of the results. Since November 2014, the FLISR system has operated 33 times, saving about 1.4 million customer outage minutes. CGEMC tracks three metrics to understand the reliability performance of the distribution system.

The reliability metrics are summarized below.

Reliability	5-Year Average (2010-2014)	2015 Average
SAIDI	129 minutes	69 minutes
<i>Tracks the total outage time per customer, on average annually.</i>		
SAIFI	1.53 times	0.95 times
<i>Tracks how often customers are affected by an outage, on average annually.</i>		
CAIDI	84 minutes	73 minutes
<i>Tracks how long on average it takes us to restore service during an outage.</i>		

From this information, you can see that the reliability for the CGEMC system has improved considerably. Customer outage time has been cut almost in half, and when an outage occurs, we restore power quickly.



SUMMARY OF BYLAWS ON ANNUAL MEETING; MEMBERSHIP; NOMINATION AND ELECTION OF BOARD MEMBERS; AND BOARD REPRESENTATION

ANNUAL MEETING DATE WEDNESDAY, AUGUST 3, 2016

The Bylaws of the cooperative require that the Annual Meeting be held each year at such date, time, and place in one of the counties in Georgia within which the cooperative serves, and beginning at such hour, as the Board of Directors shall from year to year designate. The purpose of the meeting is to elect directors, to pass upon reports covering the previous fiscal year, and to transact such other business as may come before the meeting. The Board of Directors has set the Annual Meeting for Wednesday, August 3, 2016, at 10 a.m. at the Central Georgia EMC Annex Courtyard, 1083 Mulberry Street, Jackson, Ga. 30233.

COOPERATIVE MEMBERSHIP

Each member who is not in a status of suspension, as provided for in Section 2.01 of the Bylaws, shall be entitled to only one vote upon each matter submitted to a vote at any meeting of the members. Any person, firm, or corporation may become a member of the cooperative by filing an application for membership; paying a membership fee; and agreeing to purchase electric power and energy from the cooperative. The applicant further agrees to be bound by and comply with the cooperative's Articles of Incorporation and Bylaws, and all rules, regulations, rate classifications, and rate schedules as exist or may thereafter be adopted or amended.

Warm Weather Electrical Safety Tips

Make sure electrical safety is on your list while you are taking care of outside chores and projects.

- **Keep power cords away from water** because electricity and water do not mix. When dealing with electricity, be sure you are working in an entirely dry environment.
- **Inspect power tools and electric lawn mowers before every use.** Frayed power cords, broken plugs, and weathered or damaged housings can make your equipment dangerous to use. Keep tools unplugged and dry when not in use.
- **Be aware of overhead power lines.** If your spring cleaning involves using a ladder, a rooftop, or using a long-handled pool-cleaning tool, stay more than 15 feet clear of overhead power lines at all times. Treat all power lines as if they are harmful.
- **Keep your underground transformer clear of vegetation.** The large green, ground-level box in your yard houses the components of an underground electrical system. Keeping the transformer area clear of vegetation and other permanent structures provides utility workers access for maintenance and reduces the risk of electrocution. Remind children not to sit on or play near these boxes.
- **Always call before you dig.** Underground power lines are just as dangerous as overhead, and because they are buried, they are impossible to see. If your plans involve digging of any kind, make sure you call 811 to confirm you will dig safely.
- **Never fly kites, drones, or release balloons near power lines.** If you happen to get one tangled, do not try to get the item down yourself. Call CGEMC for safe removal. Make sure you never use any metallic materials in kites or balloons as they can conduct electricity back to you.
