ENERGY STAR® ELECTRIC HEAT PUMP

Air-source heat pumps use the difference between outdoor and indoor air temperatures to cool and heat your home. Energy Star qualified heat pumps have a higher Seasonal Energy Efficiency Ratio (SEER) and Energy Efficiency Ratio (EER) than standard models. Energy Star air-source heat pumps are an efficient way to heat and cool your home.

Central Georgia EMC offers a \$400 rebate for the installation of a total electric Energy Star qualified air-source heat pump **with** the installation of a load management switch.

ENERGY STAR® MINI-SPLIT HEAT PUMP

A mini-split heat pump system can heat or cool specific zones of your home. The system has indoor and outdoor units, using refrigerant to absorb and release heat, providing efficient and flexible heating and cooling for individual areas.

Central Georgia EMC offers a \$400 rebate for the installation of a total electric Energy Star qualified mini-split heat pump system **with** the installation of a load management switch and a \$200 rebate for the same system installed **without** a load management switch.

WATER HEATERS*

The water heater is the second largest energy user in a home. Electric storage water heaters are economical and efficient. They are simple and convenient with low standby heat loss. The average U.S. household spends between \$400 and \$600 per year to heat water for showers, dishwashing, and other daily activities.

Central Georgia EMC offers a \$100 rebate for the installation of an electric storage water heater, 40 gallons or larger, **with** the installation of a load management switch.

**Tankless water heaters do not qualify for rebates.*

A load management switch must be installed on qualifying equipment by a Central Georgia EMC employee before the rebate can be processed. The load management switch must remain on equipment and in operating status as long as Central Georgia EMC has a load management program. Limit one (1) qualifying heat pump and/or one (1) qualifying water heater rebate per member/household. Heat pump and/or water heater must have been installed on or after January 1, 2024.

For your participation in the load management program, you will receive a bill credit in November of up to \$30 (\$20 for HVAC/mini-split load management switch, \$10 for water heater). Rebates are subject to change without notice. This rebate program ends December 20, 2024.
